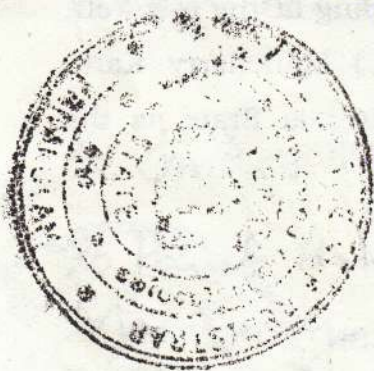

WHEREAS a Deed of Trust by name **THE NAZARETH ENGLISH MEDIUM SCHOOL** was originally executed on 04.01.1996 by the St. Joseph's Province of CSN Congregation the first party above with another member of the Congregation and duly registered with trust fund of value Rs.1,000/- (Rupees one thousand only) before the Sub Registrar, Ernakulam on 04.01.1996 with Registration No. 7/IV/SRO/EKM/1996 in Book No.IV, Volume 406, pages from 117 to 120 of Sub Registry Office Ernakulam, the Trust Deed is hereinafter referred to as Principal Trust Deed.

AND WHEREAS the activities of the Trust was carrying on smoothly by the Trustees taken charge from time to time.


AND WHEREAS the settlers now find it necessary to incorporate some more provisions to the Principal Trust Deed in order to comply with certain requirements under the Income Tax Act, 1961.

AND WHEREAS the members of settlers, St. Joseph's Province CSN Congregation, in their Meeting held on 05.10.2016 authorized the present Councillor for Education Sr. Pushpa CSN to amend the Principal Trust Deed for the above purpose, by executing a Supplementary Deed, and to get it registered before the Sub Registrar, Ernakulam.

NOW THIS SUPPLEMENTARY DEED OF TRUST Witnesses as follows :-

After sub clause (b) of clause 11 of the Principal Trust Deed the following sub clause are added.

- c) *The beneficiaries of the Trust shall be the public at large irrespective of caste, creed, community, religion and sex.*
- d) *The area of operation of the Trust shall be only within India.*
- e) *The Trust is irrevocable*
- f) *No funds or benefits from the Trust shall be taken away or enjoyed by the Settlers, Trustees, Founders or Members of the Trust but the funds should be utilized only for carrying out the objectives of the Trust.*
